

**Official Rules**  
**“America’s Best Dance Crew Finale Sweepstakes”**  
**Sponsored by**  
**MTV Networks, a division of Viacom International Inc.**

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA AND HAWAII AND WHERE PROHIBITED OR RESTRICTED BY LAW.
2. **Entry Period:** “America’s Best Dance Crew Sweepstakes” (the “Sweepstakes”) commences at 12:00:01 AM (EST) on January 22, 2009 and ends at 11:59:59 PM (EST) on February 12, 2009 (the “Sweepstakes Period”). All entries must be received by 11:59:59 PM (EST) on February 12, 2009.
3. **Eligibility:** This Sweepstakes is open to legal residents of the 48 contiguous United States and District of Columbia, EXCLUDING ALASKA AND HAWAII. Entrants must be at least 16 years of age or older at time of entry. If entrant is not the age of majority in the jurisdiction in which entrant resides, entrant will need to obtain permission from his/her parent/legal guardian in order to enter be declared the Grand Prize Winner. Employees and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of MTV Networks, a division of Viacom International Inc. (“MTVN”) and its parent company, affiliated companies, subsidiaries, sponsors, advertising agencies and third party fulfillment agencies and their respective agents, employees, officers, directors, successors and assigns (collectively, “Released Parties”) are not eligible to enter Sweepstakes. By participating in this Sweepstakes, entrants: (a) agree to be bound by these Official Rules and by the interpretations of these Official Rules by MTVN, and by the decisions of MTVN, which are final and binding in all matters relating to the Sweepstakes; (b) release and hold harmless Released Parties against any and all claims, injury or damage arising out of or relating to participation in this Sweepstakes and/or use or misuse or redemption of the Grand Prize (as hereinafter defined); and (c) acknowledge compliance with these Official Rules.
4. **To Enter:** Visit <http://clearasil.mtv.com>, a website owned and controlled by MTVN (the “Website”), at any time during the Sweepstakes Period and complete all the required fields on the online entry form. Entrants must also electronically acknowledge and agree to the terms of MTVN’s Privacy Policy and Terms of Use and submit the online entry form as instructed. In the event of a dispute over who submitted a winning online entry the authorized subscriber of the e-mail account used to participate in this Sweepstakes at the actual time of entry, will be deemed to be the Online Entrant. The authorized account subscriber is defined as the natural person who is assigned an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, education, institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. All entries become the property of MTVN and will not be acknowledged or returned. All entries submitted in accordance with these Official Rules shall be collectively hereinafter referred to as the “Eligible Entries.” The odds of winning the Sweepstakes depend on the number of Eligible Entries received.
5. **Grand Prize Winner Selection/Notification:** There will be one (1) Grand Prize Winner randomly selected from among all of the Eligible Entries on or about February 19, 2009. MTVN will make up to two (2) attempts over the 48 hour period following Grand Prize Winner selection to contact the potential Grand Prize Winner via the email address provided on his/her entry form. If the potential Grand Prize Winner cannot be reached during the 48 hour period in which he/she is called (no messages will be left on answering machines or voicemail systems) the potential Grand Prize Winner will be disqualified. Due to the time restraint as to when the Grand Prize trip must be taken, only if time permits, will an alternate Grand Prize Winner will be selected from among the remaining applicable Eligible Entries received.
6. **Grand Prize Winner Verification:** The potential Grand Prize Winner must prove eligibility, including, without limitation, proof of age and residence within three (3) days of being notified as the potential Grand Prize Winner. In the event of non-compliance by the potential Grand Prize Winner such potential Grand Prize Winner shall be disqualified and all privileges otherwise due as the Grand Prize Winner shall be terminated and an alternative potential Grand Prize Winner may be chosen from among all of the remaining applicable Eligible Entries received in MTVN’s sole discretion. The Grand Prize Winner and Guest (as defined herein) must sign (and each of his/her parent(s)/legal guardian(s) must sign if Grand Prize Winner and/or Guest is not the age of majority in the jurisdiction

in which his/she resides) within three (3) days of receipt of such documents from MTVN: (a) an affidavit of eligibility and release of Released Parties from any and all liability, loss, claims, demands, and causes of action for personal injury and/or damage, theft, loss, or any other harm suffered in connection with this Sweepstakes or the use/misuse or acceptance of any Grand Prize or any portion thereof to be eligible for the Grand Prize; and (b) except where prohibited by law, a promotional release granting Released Parties the right to use their name and likeness for advertising and publicity purposes without additional compensation. Entry into this Sweepstakes constitutes agreement to sign such releases. Grand Prize Winner and Guest also must acknowledge that MTVN has not and will not obtain or provide insurance of any kind relating to the Grand Prize and that Grand Prize Winner and Guest (and each of his/her parent(s)/legal guardian(s) must sign if Grand Prize Winner and/or Guest is not the age of majority in the jurisdiction in which he/she resides) will be responsible for obtaining and paying for any life, travel, accident, property or other form of insurance relating to the Grand Prize. Grand Prize Winner and Guest must also complete any additional legal documents provided by MTVN (or third party on its behalf, if applicable) with respect to the Grand Prize and return them as instructed within the time frame specified by MTVN or Grand Prize Winner may forfeit Grand Prize at MTVN's sole discretion. All decisions of MTVN relating to the Sweepstakes are final and binding. MTVN expressly reserves the right to delay the announcement of the Grand Prize Winner for creative or technical reasons or for any other reason MTVN deems necessary.

7. **Grand Prize:** The Grand Prize is a trip for two (2) for the one (1) grand prize winner ("Grand Prize Winner") and one (1) guest (the "Guest") to travel to Los Angeles, CA (the "Location") at MTVN's sole discretion, to attend the America's Best Dance Crew Finale currently scheduled to occur on or about March 2, 2009 (the "Event"). The Event, Event date and Location are subject to change in MTVN's sole discretion. If Grand Prize Winner cannot travel on dates specified by MTVN, Grand Prize Winner will forfeit all rights to the Grand Prize (as defined below). MTVN is not responsible if potential Grand Prize Winner is unable or unavailable to accept prize. The trip will include (i) roundtrip coach class air transportation for Grand Prize Winner and Guest which shall originate from an airport of MTVN's choice nearest Grand Prize Winner's residence (as determined by MTVN) to the Location. MTVN reserves the right to substitute ground transportation for air transportation if the Grand Prize Winner resides within 150 miles of the Location; (ii) round trip ground transportation for Grand Prize Winner and Guest (to be taken together) between airport and hotel at the Location and between hotel and Event; (iii) two (2) nights hotel accommodations at the Location for Grand Prize Winner and Guest which shall be one room based on double occupancy (meals, telephone calls, tips and other incidentals and costs are not included); (iv) \$100.00 per diem for two (2) days for a total of \$200.00 for the Grand Prize Winner; and (vii) two (2) tickets to the Event (collectively, the "Grand Prize").

The approximate retail value ("ARV") of the Grand Prize is \$4,000.00. The ARV is subject to change based on current market conditions at time of Grand Prize fulfillment and the time of travel and the distance between departure and destination. Any difference between the ARV and the actual value, if any, will not be awarded. If, for any reason, MTVN is unable to provide tickets to the Event, MTVN's only obligation is to award trip portion of the Grand Prize or a prize of equal or greater value (which may include a cash prize equal to the ARV of the trip portion of the Grand Prize), in MTVN's sole discretion. No other substitution, transfer or cash equivalent permitted. MTVN reserves the right not to award the Grand Prize if it determines, in its sole discretion, that an insufficient number of Eligible Entries were received during the Sweepstakes Period.

If a Grand Prize Winner is not available to travel on the dates specified by MTVN in its sole discretion, Grand Prize Winner privileges and Grand Prize will be terminated and an alternative Grand Prize Winner will be selected from the remaining Eligible Entries if time permits. Grand Prize Winner and Guest must travel on the same itinerary. Guest traveling with Grand Prize Winner must be at time of Grand Prize fulfillment the age of majority in the jurisdiction in which he/she resides. If Grand Prize Winner is not the age of majority in the jurisdiction in which Grand Prize Winner resides, he/she must be accompanied by his/her parent/legal guardian, and such person must pay his/her own expenses unless deemed to be the allotted Guest. MTVN will determine the airline and hotel in its sole discretion. Travel restrictions, conditions and limitations may apply. Grand Prize Winner and Guest must possess valid travel documents in order to travel. Travel arrangements are subject to availability and must be roundtrip. MTVN shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the air carriers, hotels or other transportation companies or any other persons providing any of these services and accommodations necessitated by same. MTVN shall not be liable for any loss or damage to baggage. All travel dates are subject to change in MTVN's sole discretion. If, for any reason, any Grand Prize related event is delayed, cancelled or postponed, MTVN reserves the right, but is not obligated, to cancel or modify the Sweepstakes in its discretion and

shall award a substitute prize of equal or greater value, which may include, but is not limited to, a cash prize equivalent to the ARV of the trip portion of the Grand Prize as set forth in these Official Rules. The dates for fulfillment of the Grand Prize will be on or around February 28, 2009 to March 3, 2009, subject to programming requirements and such dates are subject to change in MTVN's sole discretion.

8. **General Prize Terms:** Arrangements for fulfillment of the Grand Prize, including, but not limited to, all travel arrangements, will be made by MTVN. All costs and expenses not specifically listed above, including, without limitation, meals, snacks, beverages, mini-bar, entertainment, tips, souvenirs, personal expenses, damages to hotel rooms and any equipment to be used in connection with the Grand Prize are solely Grand Prize Winner's responsibility. The value of the Grand Prize will be taxable to Grand Prize Winner as income. Grand Prize Winner must supply MTVN with his/her social security number for tax purposes. An IRS Form 1099 will be issued in the name of Grand Prize Winner for the actual value of the Grand Prize received. Upon entry into the Sweepstakes, Grand Prize Winner (as well as all other entrants) is required to comply with any and all applicable federal, state, and local laws, rules, and regulations. All federal, state and local taxes, and any other costs not specifically provided for in these Official Rules are solely the Grand Prize Winner's responsibility. MTVN shall have no responsibility or obligation to a Grand Prize Winner or potential Grand Prize Winner who is unable or unavailable to accept or utilize Grand Prize as described herein.

MTVN reserves the right in its sole discretion to disqualify any individual it suspects or finds: (i) to have used a software-generated, robotic, programmed, script, macro or other automated online or text message entry; (ii) to have tampered with the entry process or the operation of this Sweepstakes; (iii) to be acting in violation of these Official Rules; (iv) to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person; or (v) to have provided inaccurate information on any legal documents submitted in connection with this Sweepstakes.
