

**Official Rules**  
**“Far Cry 2 and The Island Present: The Ultimate Jeep® Giveaway”**  
**Sponsored by**  
**MTV Networks, a division of Viacom International Inc., and Ubisoft, Inc.**

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA AND HAWAII AND WHERE PROHIBITED OR RESTRICTED BY LAW.
2. **Entry Period:** The “Far Cry 2 and The Island Present: The Ultimate Jeep® Giveaway” (the “Sweepstakes”) commences at 12:00:01 AM (ET) on October 15, 2008 and ends at 11:59:59 PM (ET) on November 7, 2008 (the “Sweepstakes Period”). All entries must be received by 11:59:59 PM (ET) on November 7, 2008.
3. **Eligibility:** This Sweepstakes is open to legal residents of the 48 contiguous United States and District of Columbia EXCLUDING ALASKA AND HAWAII. Entrants must be at least 18 years of age or older at time of entry and possess a valid United States driver’s license. If 18 is not the age of majority in the jurisdiction where entrant resides, then entrant will be required to get parent/legal guardian consent in order to enter Sweepstakes. Employees and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of MTV Networks, a division of Viacom International Inc. (“MTVN”), Ubisoft, Inc. (“UB” and, together with MTVN and UB, the “Sponsors”) and each of their respective affiliated companies, sponsors, subsidiaries, advertising agencies, third party fulfillment agencies (collectively with Sponsors, the “Sponsor Entities”) and any person who has won an MTVN or UB contest or sweepstakes in the preceding twelve (12) month period, are not eligible. 4. **To Enter:** Visit [www.farcry2.mtv.com](http://www.farcry2.mtv.com), a web site owned and controlled by MTVN and complete all required fields on the online entry form. Entrants must also electronically acknowledge and agree to the terms of MTVN’s Privacy Policy and Terms of Use and submit the online entry form as instructed. All entries submitted in accordance with these Official Rules shall be hereinafter referred to as “Eligible Entries”. Limit one (1) entry per entrant. If an entrant uses multiple e-mail addresses to submit more than one online entry, only the first online entry will count. In the event of a dispute over who submitted a winning online entry, the authorized subscriber of the e-mail account used to participate in the Sweepstakes at the actual time of entry, will be deemed to be the entrant. The authorized account subscriber is defined as the natural person who is assigned an e-mail address by an Internet access provider, online service provider or other organization (e.g. business, education, institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Entrants may be required to provide us with proof that he/she is the authorized account holder of the associated e-mail address. 5. **Grand Prize Winner Selection/Notification:** One (1) grand prize winner (the “Grand Prize Winner”) will be randomly selected on or about the week of November 17, 2008 from all Eligible Entries received. The odds of winning depend on the number of Eligible Entries received. Sponsors will make up to two (2) attempts over the 48 hour period following Grand Prize Winner selection to contact the potential Grand Prize Winner via the telephone number(s) provided on their online entry forms. If the potential Grand Prize Winner cannot be reached during the 48 hour period in which he/she is called (no messages will be left on answering machines or voicemail systems) the potential Grand Prize Winner will be disqualified and an alternate Grand Prize Winner will be selected from among the remaining Eligible Entries received.
6. **Grand Prize Winner Verification:** The potential Grand Prize Winner must prove eligibility, including, without limitation, proof of age and residence within three (3) days of being notified as a potential Grand Prize Winner. **7. Grand Prize:** The Grand Prize Winner will receive one (1) 2009 *Jeep® Wrangler Unlimited X (4X2)* model vehicle (the "Grand Prize").

The ARV of the Grand Prize is \$22,915.00. The ARV is subject to change based on current market conditions at time of Grand Prize fulfillment. Any difference between the ARV and the actual value, if any, will not be rewarded.

If for any reason any prize-related event is delayed, cancelled or postponed, the Sponsors reserve the right, but are not obligated, to cancel or modify the Sweepstakes in their discretion and shall award a substitute prize of equal or greater value, which may include, but is not limited to, the ARV of the Grand Prize.
