

**Official Rules**  
**“Jackass Sweepstakes”**  
**Sponsored by**  
**MTV Networks, a division of Viacom International Inc.**

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA AND HAWAII AND WHERE PROHIBITED OR RESTRICTED BY LAW.

2. **Entry Period:** “Jackass Sweepstakes” commences at 10:00:01 AM (ET) on August 26, 2010 and ends at 9:59:59 AM (ET) on September 15, 2010 (the “Sweepstakes Period”). All entries must be received by 9:59:59 AM (ET) on September 15, 2010.

3. **Eligibility:** This Sweepstakes is open to legal residents of the 48 contiguous United States and District of Columbia. Entrants must be at least 18 years of age or older at time of entry. If 18 is not the age of majority in the jurisdiction in which entrant resides, entrant will need to obtain permission from their parent/legal guardian in order to enter and be declared a Winner. Employees and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of MTV Networks, a division of Viacom International Inc. (“MTVN” or “Sponsor”), and its affiliated companies, sponsors, subsidiaries, advertising agencies and third party fulfillment agencies (collectively “Sweepstakes Entities”) are not eligible to enter Sweepstakes. By participating in this Sweepstakes, entrants: (a) agree to be bound by these Official Rules and by the interpretations of these Official Rules by MTVN, and by the decisions of MTVN, which are final in all matters relating to the Sweepstakes; (b) release and hold harmless Sweepstakes Entities and its respective agents, employees, officers, directors, successors and assigns, against any and all claims, injury or damage arising out of or relating to participation in this Sweepstakes and/or use or misuse or redemption of a Prize (as hereinafter defined); and (c) acknowledge compliance with these Official Rules.

4. **To Enter:** Visit <http://jackass3dsweeps.mtv.com>, a website owned and controlled by MTVN (the “Website”), and complete all required fields on the online entry form. Entrants must also electronically acknowledge and agree to the terms of the Website’s Privacy Policy and Terms of Use and submit the online entry form as instructed (the “Online Entrants”). Online Entrants may enter as many times as they wish. In the event of a dispute over who submitted a winning online entry the authorized subscriber of the e-mail account used to participate in this Sweepstakes at the actual time of entry, will be deemed to be the Online Entrant. The authorized account subscriber is defined as the natural person who is assigned an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, education, institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. All entries become the property of MTVN and will not be acknowledged or returned. All entries submitted in accordance with these Official Rules shall be collectively hereinafter referred to as the “Eligible Entries.” The odds of winning the Sweepstakes depend on the number of Eligible Entries received.

5. **Winners Selection/Notification:** There will be one (1) grand prize winner (the “Grand Prize Winner”) and ten (10) first place winners (the “First Place Winners” and, collectively with the Grand Prize Winner, the “Winners”) randomly selected on or around September 17, 2010 from among all of the Eligible Entries received. MTVN will make up to two (2) attempts over the 48 hour period following the Winners’ selection to contact each potential Winner via the telephone number(s) and/or email address provided on his/her entry form. If a potential Winner cannot be reached during the 48 hour period in which he/she is called (no messages will be left on answering machines or voicemail systems) or emailed the potential Winner will be disqualified and an alternate Winner will be selected from among the remaining applicable Eligible Entries received, if time permits.

6. **Winners Verification:** Each potential Winner must prove eligibility, including, without limitation, proof of age and residence within three (3) days of being notified as a potential Winner. In the event of non-compliance by a potential Winner, such potential Winner shall be disqualified and all privileges otherwise due as a Winner shall be terminated and an alternative potential Winner may be chosen from among all of the remaining applicable Eligible Entries received in MTVN’s sole discretion. Each Winner must sign (his/her parent/legal guardian must sign if Winner is a resident of a jurisdiction that deems him/her to be a minor) within three (3) days of receipt of such

documents from MTVN: (a) an affidavit of eligibility and release of Sweepstakes Entities from any and all liability, loss, claims, demands, and causes of action for personal injury and/or damage, theft, loss, or any other harm suffered in connection with these Sweepstakes or the use/misuse or acceptance of the Prize or any portion thereof to be eligible for the Prize; and (b) except where prohibited by law, a promotional release granting Sweepstakes Entities the right to use their name and likeness for advertising and publicity purposes without additional compensation. Entry into these Sweepstakes constitutes agreement to sign such releases. Each Winner also must acknowledge that Sweepstakes Entities have not and will not obtain or provide insurance of any kind relating to the Prize and that the Winner (his/her parent/legal guardian must sign if Winner is a resident of a jurisdiction that deems him/her to be a minor) will be responsible for obtaining and paying for any life, travel, accident, property or other form of insurance relating to the Prize. Each Winner must also complete any additional legal documents provided by MTVN (or third party on its behalf, if applicable) with respect to the Prize and return them as instructed within the timeframe specified by MTVN or a Winner may forfeit the Prize at MTVN's sole discretion. All decisions of MTVN relating to these Sweepstakes are final. MTVN expressly reserves the right to delay the announcement of the Winners for creative or technical reasons or for any other reason MTVN deems necessary.

## 7. Prizes:

**(a) Grand Prize:** The Grand Prize Winner will receive a trip for two (2) to be used by the Grand Prize Winner and his/her one (1) guest (the "Guest") to Los Angeles, CA to attend the premiere of Jackass 3-D with "Jackass" cast members in attendance, currently scheduled for October 13, 2010 (the "Event"). Event and Event dates subject to change. If Grand Prize Winner cannot travel on dates specified by MTVN, Grand Prize Winner will forfeit all rights to the Grand Prize. MTVN is not responsible if potential Grand Prize Winner is unable or unavailable to accept Grand Prize. The trip will include: (i) roundtrip coach class air transportation for Grand Prize Winner and Guest which shall originate from a major U.S. gateway airport of MTVN's choice nearest Grand Prize Winner's residence (as determined by MTVN) to Los Angeles, CA. MTVN reserves the right to substitute ground transportation if Grand Prize Winner resides within 150 miles of Los Angeles, CA; (ii) round trip ground transportation for Grand Prize Winner and Guest (to be taken together) between airport and hotel in Los Angeles, CA and between hotel and Event; (iii) two (2) night standard hotel accommodations in Los Angeles, CA for Grand Prize Winner and Guest which shall be one (1) room based on double occupancy (meals, telephone calls, tips and other incidentals and costs are not included) and (iv) access for two (2) for the Grand Prize Winner and his/her Guest to the Event (collectively, the "Grand Prize").

If the Grand Prize Winner is not available to travel on the dates specified by MTVN in its sole discretion, Grand Prize Winner privileges and Grand Prize will be terminated and an alternative Grand Prize Winner will be selected from the remaining Eligible Entries, if time permits. Grand Prize Winner and Guest must travel on the same itinerary. Grand Prize Winner and Guest must travel on the dates specified by MTVN or the Grand Prize will be forfeited. Guest traveling with Grand Prize Winner must be at time of Grand Prize fulfillment the age of majority in the jurisdiction in which he/she resides, unless accompanied by a parent or legal guardian. If 18 is not the age of majority in the jurisdiction in which Grand Prize Winner resides, he/she must be accompanied by his/her parent/legal guardian, and such person must pay his/her own expenses unless deemed to be the allotted Guest. MTVN will determine the airline and hotel in its sole discretion. Travel restrictions, conditions and limitations may apply. Travel arrangements are subject to availability and must be roundtrip. MTVN shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the air carriers, hotels or other transportation companies or any other persons providing any of these services and accommodations necessitated by same. MTVN shall not be liable for any loss or damage to baggage. All travel dates are subject to change in MTVN's sole discretion. If for any reason any Grand Prize related event is delayed, cancelled or postponed, MTVN reserves the right, but is not obligated, to cancel or modify the Sweepstakes in its discretion and shall award a substitute prize of equal or greater value, which may include, but is not limited to, a cash prize equivalent to the ARV of the trip portion of the Grand Prize as set forth in these Official Rules. The dates for fulfillment of the Grand Prize will be on or around October 13, 2010 to on or around October 14, 2010, subject to change in MTVN's sole discretion.

**(b) First Place Prizes:** Each First Place Winner will receive one (1) "Jackass" sunglasses by Von Zipper (the "First Place Prize") and, collectively with the Grand Prize, the "Prizes"). The date for fulfillment of the First Place Prizes will be on or around October 29, 2010.

(c) The approximate retail value (“ARV”) of the Grand Prize is \$2,200.00 depending on time of travel and departure. The ARV of each First Place Prize is \$95.00. The ARV of all Prizes is \$3,150.00 The ARV is subject to change based on current market conditions at time of Prize fulfillment and for the Grand Prize, the time of travel and the distance between departure and destination. Any difference between the ARV and the actual value, if any, will not be awarded. If, for any reason, MTVN is unable to provide the Event, MTVN’s only obligation is to award trip portion of the Grand Prize or a prize of equal or greater value (which may include a cash prize equal to the ARV of the trip portion of the Grand Prize), in Sponsor’s sole discretion. No other substitution, transfer or cash equivalent permitted.

**8. General Prize Terms:** Arrangements for fulfillment of the Prizes, including all travel arrangements, will be made by MTVN or a third party on MTVN’s behalf. The value of each Prize will be taxable to Winner as income. Each Winner must supply MTVN with his/her social security number for tax purposes. IRS Form 1099s will be issued in the name of each Winner for the actual value of the Prize received. Upon entry into these Sweepstakes, Winners (as well as all other online Entrants) are required to comply with any and all applicable federal, state, and local laws, rules, and regulations. All federal, state and local taxes, and any other costs not specifically provided for in these Official Rules are solely each Winner’s responsibility. Sweepstakes Entities shall have no responsibility or obligation to a Winner or potential Winner who is unable or unavailable to accept or utilize Prize as described herein.

No substitution, transfer or cash equivalent of the Prize or any portion thereof permitted, except by MTVN, in which case a prize of comparable or greater value may be awarded.

**9. General Terms:** Noncompliance with any of these Official Rules may result in disqualification. ANY VIOLATION OF THESE OFFICIAL RULES BY A WINNER OR ANY BEHAVIOR BY A WINNER THAT WILL BRING SUCH WINNER OR SWEEPSTAKES ENTITIES INTO DISREPUTE (IN SWEEPSTAKES ENTITIES’ SOLE DISCRETION) WILL RESULT IN SUCH WINNER’S DISQUALIFICATION AS A WINNER OF THE SWEEPSTAKES AND ALL PRIVILEGES AS A WINNER WILL BE IMMEDIATELY TERMINATED.

MTVN reserves the right in its sole discretion to disqualify any individual they suspect or find (a) to have used a software generated, robotic, programmed, script, macro or other automated online or text message entry, (b) to have tampered with the entry process or the operation of these Sweepstakes, (c) to be acting in violation of these Official Rules, (d) to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or (e) to have provided inaccurate information on any legal documents submitted in connection with these Sweepstakes.
