

**Official Rules**  
**“DC New 52 Giveaway”**  
**Sponsored by MTV Geek**

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.
2. **Entry Period:** The “DC New 52 Giveaway” (the “Sweepstakes”) commences at 2:00:01 PM (ET) on August 31, 2011 and ends at 5:59:59 PM (ET) on September 2, 2011 (the “Sweepstakes Period”). All entries must be received by 5:59:59 PM (ET) on September 2, 2011. Odds of winning depend on the total number of eligible entries received for the Sweepstakes.
3. **Eligibility:** The Sweepstakes is open to individuals who are: (i) legal residents of one (1) of the fifty (50) United States or District of Columbia, (ii) are at least thirteen (13) years of age or older at the time of entry and (iii) have a [www.twitter.com](http://www.twitter.com) account to enter. Entrants who have not yet reached the age of majority in the jurisdiction in which they reside will need to obtain permission from their parents/legal guardians in order to enter to be declared a Grand Prize Winner. Employees and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of Viacom Media Networks, a division of Viacom International Inc. (“VMN” or “Sponsor”), Twitter Inc. (“Twitter”) and each of their respective affiliated companies, sponsors, subsidiaries, advertising agencies and third party fulfillment agencies (collectively, the “Sweepstakes Entities”) are not eligible to enter this Sweepstakes. By participating in this Sweepstakes, entrants: (a) agree to be bound by these Official Rules and by the interpretations of these Official Rules by the Sponsor, and by the decisions of the Sponsor, which are final in all matters relating to this Sweepstakes; (b) release and hold harmless Sweepstakes Entities and their respective agents, employees, officers, directors, successors and assigns, against any and all claims, injury or damage arising out of or relating to participation in this Sweepstakes and/or use or misuse or redemption of a Grand Prize (as hereinafter defined); and (c) acknowledge compliance with these Official Rules.
4. **To Enter:** During the Sweepstakes Period, go to <http://www.twitter.com/MTVGeek> and from your Twitter account, follow the MTVGeek account and retweet the following tweet: “**Giving away all 52 #1 issues of DC's New 52 to two lucky followers! #Geek52 RT (copy/paste) to enter! Membership on Twitter is free, and registration for Twitter can be obtained by logging on to <http://twitter.com> (“Twitter Web Site”) and following the onscreen instructions to open an account.) BY RETWEETING THE MTVGEEK-SPECIFIED TWEET, YOU AGREE TO THESE OFFICIAL RULES. You are required to follow the Official MTVGeek Twitter account located at <http://www.twitter.com/MTVGeek> so you can see the Grand Prize Winners' announcement to see if you've won (pending verification) in addition to the winner notification described in Section 5 below. Please note that if you do not respond to the Grand Prize Winners' notification described in Section 5, you will be disqualified and another Grand Prize Winner may be selected. **You must retweet the Tweet exactly as it appears above during the Sweepstakes Period to count as one (1) entry. One (1) entry per person allowed.** Automated tweets or tweets sent via a bot will be disqualified. All entries submitted in accordance with these Official Rules shall be hereinafter referred to as “Eligible Entries”. In the event of a dispute over who submitted a winning online entry, the authorized subscriber of the Twitter account used to participate in the Sweepstakes at the actual time of entry will be deemed to be the entrant. The authorized account subscriber is defined as the natural person who is assigned a Twitter account by Twitter. All entries become the property of Sponsor and will not be acknowledged or returned. All entries must comply with the Twitter Terms of Service and Twitter Rules available at the Twitter Web Site. Creating multiple Twitter Accounts in order to exceed the limits on Entries permitted by these Official Rules may result in the disqualification of all Entries from such accounts. Important note: If your Twitter account is set to “protected mode,” your updates/responses may not be visible in Sponsor's @MTVGeek inbox and may not thus be received by Sponsor unless you previously consented to permit Sponsor to see the your Twitter updates. If you opt to use Twitter via your wireless mobile device (which may only be available via participating wireless carriers and is not required to enter the Sweepstakes), standard text messaging and/or data rates may apply for each message sent or received from your handset according to the terms and conditions of your service agreement with your wireless carrier. Other charges may apply (such as normal airtime and carrier charges) and may appear on your mobile phone bill or be deducted from your prepaid account balance. Wireless carriers' rate plans may vary, and you should contact your wireless carrier for more information on messaging rate plans and charges relating to your participation in this Sweepstakes. 5. **Grand Prize Winners Selection/Notification:** Two (2) grand prize winners (the “Grand Prize Winner(s)”) will be randomly selected on or around September 2, 2011 by Sponsor from the Eligible Entries received during the Sweepstakes Period. VMN will make up to one (1) attempt over the twenty-four (24) hour period following the Grand Prize Winners' selection to contact the potential Grand Prize Winners via each Grand Prize Winner's Twitter account and via tweets from <http://www.twitter.com/MTVGeek>. If a potential Grand Prize Winner does not respond within twenty-four (24) hours of being

contacted, such potential Grand Prize Winner will be disqualified and an alternate Grand Prize Winner will be selected from among the remaining applicable Eligible Entries received. This process will be repeated until a potential Grand Prize Winner responds.

6. **Grand Prize Winners' Verification:** The potential Grand Prize Winners must prove eligibility, including, without limitation, proof of age and residence within three (3) days of being notified as a potential Grand Prize Winner. In the event of non-compliance by a potential Grand Prize Winner such potential Grand Prize Winner shall be disqualified and all privileges otherwise due as a Grand Prize Winner shall be terminated and an alternate potential Grand Prize Winner may be chosen from among all of the remaining applicable Eligible Entries received if time permits in Sponsor's sole discretion. Failure to return all such documents and comply with any stated deadline, noncompliance with these Official Rules or the return of any prize or prize notification will result in disqualification and selection of an alternate winner. One Grand Prize Winner will receive the print version and one Grand Prize Winner will receive the digital version. The Grand Prize Winner of the digital version will receive a download code for the DC Comic application (the "Grand Prize(s)").

The approximate retail value ("ARV") of each Grand Prize is \$210.00 and the total ARV of all Grand Prizes to be awarded in this Sweepstakes is \$420.00.VMN The date for fulfillment of the Grand Prize will be on or around September 30, 2011, subject to change in VMN's sole discretion. All details relating to the Grand Prizes not stated in these Official Rules shall be determined by Sponsor in its sole discretion, including, without limitation, the manner in which the Grand Prizes will be disbursed to Grand Prize Winners.

8. **General Prize Terms:** Arrangements for fulfillment of the Grand Prizes will be made by Sponsor.
